AGREEMENT OF GUARANTY

do hereby, jointly and severally, guaranty full and prompt payment to GLENBARD ELECTRIC SUPPLY, INC. or their successors or assigns (hereinafter referred to as "Glenbard") for any and all indebtedness and obligations incurred by or on behalf of the Business before, currently and at any time hereafter to Glenbard, including but not limited to amount (s) invoiced, all costs of collection, court costs, attorney's fees all other costs of enforcing this guaranty together with interest thereon; interest shall accrue from the date of said indebtedness and of said obligations until paid in full, including accrued interest, at the rate of 18% annually, unless otherwise specified in writing by Glenbard.

The undersigned grant (s) to Glenbard a security interest in all property of the undersigned now or at any time hereafter in the possession of Glenbard to secure the payment of any liability of the undersigned under this Guaranty and Glenbard shall have the rights and remedies of a secured party under the Uniform Commercial Code of Illinois in respect to such property, including without limitation the right to sell or otherwise dispose of any or all of such property.

It is understood that this Guaranty is continuing and irrevocable for said indebtedness and said obligations. Each of the undersigned waives presentment, protest, demand, notice of dishonor of default, notice of acceptance of this Guaranty, notice of any advances of credit made, extensions granted, or other action in reliance hereon and all demands and notices of any kind in connection with this Guaranty of the indebtedness.

This Guaranty shall be governed by and shall be construed under the Laws of the State of Illinois. This Guaranty shall be construed so as to ensure the validity of each and every provision herein, wherever possible. If any provision is construed under Illinois Law to be invalid, such invalidity shall not be construed to affect remaining provisions herein.

If this Guaranty is signed by more than one person, such obligation hereunder shall be the joint and several obligations of said persons. No release or discharge of the liability of any of the undersigned shall release or discharge any of the other undersigned, unless and until all of the indebtedness shall have been fully paid and discharged.

This Guaranty and every part thereof shall be binding upon the undersigned and jointly and severally upon the heirs, legal representatives, successors and assigns of the undersigned.
